Dear Colleague,

On behalf of the organizers of Moot Shanghai 2015, we cordially invite you to act as a guest arbitrator for Moot Shanghai oral hearings taking place from March 10th to March 13th 2015.

Moot Shanghai is a practice mooting competition of the Vis Moot, which allows participating law students to apply their accumulated knowledge to practice and to enhance their arguments and oral advocacy and pitch their wits against teams with different legal traditions before experienced legal practitioners and receive valuable comment and guidance from them and thus hone their skills in a cross-cultural and multi-jurisdictional setting.

In the previous annuals, more than 300 practicing arbitrators and lawyers from both common law and civil law countries worked together as guest arbitrators. Over 500 law students from more than 10 jurisdictions acted as party representatives in more than 200 mooting rounds.

East China University of Political Science and Law and Shanghai University of Political Science and Law will organize Moot Shanghai 2015 in cooperation with ICC International Court of Arbitration and Shanghai Bar Association. More than 10 international and local law firms and legal institutions will host the competition rounds. 31 teams from 12 jurisdictions have registered to the Moot Shanghai 2015, ranking the highest among all previous annuals.

Whether you act as a guest arbitrator or not, we take this opportunity to invite you to join us in the Awarding Dinner in the evening of March 13th, 2015 at Shanghai Grand Theatre (TBC) after the Grand Final. The details will be available at www.mootshanghai.cn in the early March.
